With reference to your application No. Nil, dated **07<sup>th</sup> December 2023** for the grant of permission for proposed sub-division of land as residential plots (6 plots) at R.S.No.130/1 Ariyapalayam Main Road, Ariyapalayam, Villianur Revenue Village, Villianur Commune Panchayat, Puducherry. 1. The Layout Promoter /Owners shall not encroach any Government land/ canal /road portion adjoining or passing, through the layout, in any manner.
2. The Layout Promoter /Owner shall settle any legal disputes in the court of law in respect of the title deed and the Puducherry Planning Authority shall be indemnified.
3. The layout approval will be revoked if the same has been obtained by furnishing any false information / statement / suppression of facts or misrepresentation of material facts.
4. This approval is issued based on the opinion of the Office of the Sub Collector (Revenue) South, Villianur vide letter No.1020/SCRS/B4/PPA/LO/TOV/2024/853, dated 15.05.2024.
5. This approval is issued based on the opinion of the Directorate of Survey and Land Records report/sketch vide letter No.975/DSL/2024, dated 25.07.2024.
6. This approval is issued based on the opinion of the Office of the Executive Engineer, Electricity Department, Puducherry vide letter No.6366/ED/EE-R(N)/TECH/F.TO/2023-24, dated 02.04.2024.
7. This approval is issued based on the opinion of the Office of the Villianur Commune Panchayat, Puducherry vide NOC letter No.F.No.20-2/VCP/AE/JE(M)/PPA/2024-25/405, dated 04.09.2024.
8. This approval is issued based on the opinion of the Office of the Executive Engineer, Irrigation Division, PWD, Puducherry, vide letter No.4883/PW/EEI/DB/C-19/2023-24/3936, dated 05.03.2024.
9. The permit issued based on opinion offered by the Legal Advisor, PPA dated 22.03.2024.
10. The layout has to be registered with the Puducherry Real Estate Regulatory Authority as per the section 3 of the Real Estate (Regulation and Development) Act, 2016.
11. The provisions in the G.O.Ms.No.5/2023-Hg dated 18.05.2023 regarding placing of Telecommunication cable in a duct in the layout should be complied.
