2. This permit is issued based on the Survey Report issued by the Directorate of Survey and Land Records, Puducherry, vide letter No.630/DSL/ADOS/2023, dated 27.03.2023.
3. The Layout Promoter/Owners shall not encroach any Government land/canal/road portion adjoining or passing through the layout in any manner.
4. The Layout Promoter/Owner shall settle any legal disputes in the Court of law in respect of the title deed and the Puducherry Planning Authority shall be indemnified.
5. The layout approval will be revoked if the same has been obtained by furnishing any false information/statement /suppression of facts or misrepresentation of material facts.
6. The conditions stipulated by the Oulgaret Municipality vide letter No.F.No.50-01/AE(I)/JE(O)/O.M/2023-24, dated: 28.04.2023 should be strictly adhered to.
7. The conditions stipulated by the Irrigation division, PWD vide letter No.6202/PW/EEI/DB/C-19/2022-23/3988 dated: 16.02.2023 should be strictly adhered to.
8. The conditions stipulated by the Electricity Department vide letter No.5307/ED/EE-R(N)/TECH/F.TO/2022-23 dated: 10.02.2023 should be strictly adhered to.
9. The layout has to be registered with the Puducherry Real Estate Regulating Authority as per the section 3 of the Real Estate (Regulation and Development) Act, 2016.
